***The International Surcharge** is for any student whose permanent residence or mailing address is outside Canada or the United States.

7-Day Room and Board Plan A provides room and board for students during the school year with the exception of long weekends, Christmas and March Break.

7-Day Room and Board Plan B –Student may stay on campus during the five long weekends in the school year. **Students who do not have a Guardian in Ontario are required to select Plan B.** Dorms will be closed for two weeks during the Christmas break and one week during March break. Students are required to leave campus.
